Florida Initiative on Racinos

Here is the objective record on the Florida initiative allowing slot machines in pari-mutuel facilities in Miami-Dade and Broward Counties. These two counties are the large counties in southeastern Florida. They are the two largest counties in Florida. Miami-Dade has over 2.25 million residents, and Broward has 1.6 million residents. The existing facilities in those counties are at Calder, Gulfstream, Pompano, Dania Jai Alai, Hollywood Greyhound, Miami Jai Alai, and Flagler Greyhound. The proposal to be voted on in November state-wide amends the State Constitution to allow for slot machines at pari-mutuel facilities in the two counties. If approved by the full state, it awaits further legislative action in 2005. After the legislative action, it would then be voted on in separate authorization elections held in the two counties.

The main carrot in the amendment is that any revenue from the State taxing the slot machines is supposed to supplement public education statewide. Thus, in more culturally conservative areas of Florida, the taxpayers could conceivably have their cake and eat it too. They get added revenue for education and no gambling in their areas. Clearly the pari-mutuel facilities in Florida outside of the two counties would not stand to benefit from this amendment. There are 14 dog tracks, one thoroughbred track, and three jai alai frontons in Florida outside these two counties. Clearly hurt would be the Palm Beach Kennel Club in Palm Beach County, which is the county adjacent to Broward County. Also if slot machines are authorized in Broward County, there would be no reason to relocate Magna Entertainment's Gulfstream Park from Broward County to its Palm Meadows training facility in Palm Beach County.

Authorizes Miami-Dade and Broward Counties to hold referenda on whether to authorize slot machines in existing, licensed parimutuel facilities (thoroughbred and harness racing, greyhound racing, and jai alai) that have conducted live racing or games in that county during each of the last two calendar years before effective date of this amendment. The Legislature may tax slot machine revenues, and any such taxes must supplement public education funding statewide. Requires implementing legislation.

Note that the wording of the proposal would prevent Hialeah (which is in Miami-Dade) from being eligible for slot machines. In order to be eligible, a facility would have had to run races or conduct games in both the last two calendar years before the amendment was approved. Hialeah last raced in 2001.

Contributions to Floridians for a Level Playing Field – principal committee supporting the proposal.

N.B. – No Magna contributions to this committee. It’s not as if Magna is opposed to racinos. Their Florida contributions are detailed below, and in 2004 in California, as of July 31, they had spent \$1.8 million in political donations. \$1.6 million of that amount has been spent on Proposition 68 which would authorize racinos in California. Calder/ Churchill has already contributed \$3.425 million to this initiative. Churchill has already made \$979,000 worth of political contributions in California in 2004 with a total of \$947,000 (which includes one 2003 contribution) to the racino initiative. <http://calaccess.ss.ca.gov/Campaign/Committees/Detail.aspx?id=1016276&view=contributions> Stockholders in Magna and Churchill should recognize that their potential profits are being largely spent in election contests.

Isle of Capri/Pompano Park Harness has contributed \$3.65 million. West Flagler Associates/Flagler Greyhound has contributed \$3.263 million, and Hollywood Greyhound/ Hartman and Tyner has contributed \$3.095.5 million. In addition, Hartman and Tyner’s subsidiaries Hazel Park in Michigan (\$50,000) and Tri-State in West Virginia (\$325,000) have made significant contributions to the pro-racino committee. Also, where are Dania Jai Alai and Miami Jai Alai which both would stand to benefit from this amendment?

I’m also attaching Magna/ Gulfstream’s 2004 contributions and Calder/Churchill’s 2004 contributions for comparison.
